# Message From President MANNON



With the Inaugural Issue of "In UNITY" behind us, I'd like to thank all those who showed their enthusiasm and excitement for our first issue. Your responses came via the telephone and e-mail — from both Active members and Retirees, who were thankful they were not forgotten. Even though the Retirees did not recognize most of the faces in the newsletter, their connection to the history of this Union is second to none. That's why I named it "IN UNITY."

I would like to thank Marci Rosenblum of RWD Group, our newsletter designer. She has done a wonderful job with the newsletter. The professional approach she has put into our newsletter is appreciated by all those who read it. Special thanks also goes to Frank Mazzocchi, 1st Vice-President, for all of the pictures he contributed to the newsletter. We received many calls at the Hall from members not believing that Frank actually had film in his camera. The myth of Frankie taking pictures and no one ever seeing them is now over — I hope!

While trying to keep the newsletter budget down and still mail to all Active and Retired members, I made the decision to use bulk mail. The delivery time was slower than expected and members received it spread out over the course of several weeks. I am studying this matter closely and will make a decision on how to mail future issues based on how quickly and methodically this issue get delivered. Keep in mind that you should still use our website for all important updates, especially those that are time sensitive, and affect you personally.

There has been much talk about the de-affiliation of our International Union, the SEIU (Service Employees International Union) from the AFL-CIO. This issue was brought up at the last International Convention. The International Executive Board, along with a majority of Delegates, voted to give International President Andy Stern the power to de-affiliate if needed. Apparently this was his choice. We at SOA will be removing the AFL-CIO logo from all future correspondence. It was highly recommended, however, that we still keep a working relationship with our State AFL-CIO and Central Labor Council (CLC). We will continue to pay our dues and be a part of these organizations until mandated differently by our International Union.

We are not alone in this endeavor. The SEIU and Teamsters (IBT) took the lead in this de-affiliation effort and formed the new "Change to Win Coalition." Other unions that defected from the AFL-CIO and joined the new Coalition include: UFCW (United Food & Commercial Workers), UNITE, HERE (Textile & Hotels), LIUNA (Laborers International Union of North America), UFW (United Farm Workers), and UBC (United Brotherhood of Carpenters and Joiners of America). These unions will now be working together in pursuit of goals that best benefit all involved.

This is not much different than what SEIU Local 444 and Local 831 IBT have done in Albany to benefit all of our members together. By working together — In Unity — we all accomplish so much more than by fighting for causes alone, or fighting with each other. There is so much going on with this effort that it would be impossible for me to say it all here. I urge you to visit the following web sites for more details: www.changetowin.org and www.unitetowin.org. I will keep you posted in future issues of "In UNITY" as to the status of the defection and the new Change to Win Coalition.

Secretary-Treasurer Glenn Ferber and I are still working on completing the updates to our benefit books, so please be patient. Trustees are currently working on an improved death benefit for Active and Retired members. Details can be found in this newsletter.

As this is only our second issue, and we are still developing ideas and concepts on ways to make it the best possible publication for our membership, please continue to let us know what you think. Keep your comments and suggestions coming in. I will try to publish some of them, space permitting of course.

In Unity, we can make this the best possible newsletter by keeping it educational, informative, and fun to read.

Allen discussed in detail the current contracts that were negotiated or arbitrated. He referenced the DC 37, Local 237, Local 246, The Doctors Council and the PBA Award and let our delegates know how patterns are set and the challenges to other Unions that follow. Allen also proposed ideas and challenges to our Delegates. He challenged us all to come up with ideas for our own upcoming negotiations.

Our second speaker was Mark S. Soroka from the law firm Taubman Kimelman & Soroka. Mark has been the Union's and Fund's attorney for many years, and will be our attorney for the upcoming negotiations. Mark and Joe Castagno have been working hand in hand on all of our

ongoing grievances and we are confident that we will prevail.

Mark went over in detail each of our grievances and improper practices against the Department. He also explained procedures of negotiations, mediation and arbitration. Both Allen and Mark ignited several discussions amongst the Delegates.

On Sunday, Delegates met again to discuss the upcoming negotiations and set up Outer Boro meetings to bring our members up to speed. We want our members to be well informed. An educated member will suppress all of the false rumors that are out there.

We discussed future Convention sites and how to get more Shop Stewards involved and qualified to attend. Several rules were reviewed. We talked about some upcoming events and how they affect our rules.

Frank discussed a pension issue that can have unfavorable impacts on our members if they do not follow through. I'm referring to the 521 Form from NYCERS. Frank has written about it in this issue on page 4.

This Convention is set up as a learning event and we did spend many hours being educated by our speakers and from each other during our discussions. We also had time to enjoy each others company and share some personal moments with each other. I believe all left with a wider understanding of what's going on and is ready and willing to spread that knowledge with their fellow brothers and sisters in the field. "In Unity" there is knowledge and strength.

### A Brief NOTE

RETIREES & MEDICARE PART B REIMBURSE-MENT — The City mailed out Medicare Part B reimbursements in the beginning of August. You should have received this already if you qualify. If you have not, call NYC Employee Benefits at (212) 513-0470. For more info refer to our web site www.Local444SEIU.com

#### ATTENTION RETIREES

— By now you should have received reimbursement for the 2004 High Option Rider — up to \$700 for those up to age 64 and \$800 for ages 65 and older. To receive this reimbursement from the Retiree Welfare Fund, send copies of your pension quarterly statements or pension stubs indicating payment for the High Option Rider. Be sure to include your name, address and social security number. Mail your quarterly statements/pension stubs to:

> A.S.O., P.O. Box 9005, Lynbrook, NY 11563, Attn: High Rider Reimbursement

If you are not certain that you received this reimbursement call (516) 396-5525 or (800) 537-1238. If you cannot locate your stubs or quarterly statements call NYCERS at (347) 643-3000 and ask for a 2004 print out. As with all other claims, no claim will be honored if it is older then one year. Do not confuse this reimbursement with your Medicare Part B reimbursement.

# Message From 1st Vice President MAZZOCCH



Anyone thinking of retiring should learn about the Retirement System and all it has to offer. In preparing for retirement, there are many things to consider and decisions to make, such as your salary and a health insurance plan that will cover you during this time. One reason the latter is so important is because if you plan to relocate, the health insurance plan you choose will have to cover you at your new address.

Preparing for the future means knowing what's in store, anticipating the unknown and being able to handle everything as it happens.

Another issue that should not be overlooked is activating your transitional option regarding death benefits via the 521 form. The 521 is available to all members in Tiers II, III and IV. By completing this form, your beneficiary will be protected if you die during this transitional period. The transitional period is from your Close of Business date (COB) until you receive your first full pension check.

In case you die during this period, your beneficiary will receive the pension based on which of the following two options you selected:

- ♦ 10-Year Certain Upon your death, the 10-Year Certain will obligate the Pension System to make a total payout of 10 years from your COB. It will combine the amount of time you collected a pension, subtract this from the 10-year maximum, and the remaining time is what your beneficiary will receive.
- ♦ 100% Joint and Survivor The designated beneficiary will receive 100% of your retirement allowance upon your death for the rest of his or her life.

The 521 form is a self-effectuating document, meaning that if you don't fill out this form and you die before you receive your first full pension check, then your pension is terminated. Remember this 521 form, which is completed and given to NYCERS before retirement, is only temporary. If you changed your option selection any time after completing the 521, (remember your pension options are selected after you retire) and you die, your new selection will be used to determine how and to whom your death benefit will be paid.

You will receive your 521 when you have your appointment with the Department of Sanitation Employee Benefits, 346 Broadway. The very next step is a trip to NYCERS (your Pension Bureau) where everything will be submitted. The 521 form can be accessed at the NYCERS website. You can click on their link at our own website — www.local444seiu.com

All members of Tiers II, III, and IV can file with NYCERS up to 90 days prior to the effective date of retirement (COB). If you have any questions or topics you would like covered do not hesitate to call or e-mail me at nycsoa@yahoo.com

This is a summary of the annual report for the Sanitation Officers Security Benefits Fund (EIN # 13-6181431) for the plan year ending December 31, 2004. The annual report has been filed with the Internal Revenue Service as required under the Employee Retirement Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENTS

The value of the plan assets, after subtracting liabilities of the plan was \$1,427,468 as of December 31, 2004, compared to \$1,184,996 of January 1, 2004. During the plan year the plan experienced a increase in its net assets of \$242,472. This increase included unrealized appreciation or depreciation in the value of plan assets: that is, the difference between the value of the plan's assets at the end of the year and the price that the plan originally paid for those assets.

The plan had total income of \$1,910,439 including employer contributions of \$1,874,313, COBRA contributions of \$12,582, gain on the sale of investment of \$6,502, loss on market value decrease on investments of \$6,801), and earnings from interest and dividends from investments of \$23,843.

Benefits under the plan are provided by this Fund. Plan expenses were \$1,667,967. These expenses included \$87,972 in administrative expenses and \$1,579,995 in benefits paid to participants and beneficiaries. A total of 1,133 persons were participants in or beneficiaries of the plan at the end of the plan year, and all of these persons have earned the right to receive benefits. All benefits are paid directly by the Fund. There are no insurance contracts for any benefits.

This is a summary of the annual report for the Sanitation Officers Retirees Welfare Fund (EIN # 13-2854090) for the plan year ending December 31, 2004. The annual report has been filed with the Internal Revenue Service as required under the Employee Retirement Security Act of 1974 (ERISA).

#### BASIC FINANCIAL STATEMENTS

The value of the plan assets, after subtracting liabilities of the plan was \$8,059,415 as of December 31, 2004, compared to \$7,690,394 as of January 1, 2004. During the plan year the plan experienced an increase in its net assets of \$369,021. This increase included unrealized appreciation or depreciation in the value of plan assets: that is, the difference between the value of the plan's assets at the end of the year and the price that the plan originally paid for those assets.

The plan had total income of \$3,574,625, including employer contributions of \$3,299,037, COBRA contributions of \$23,140, gain on the sale of investment of \$5,374, gain on market value increase of investments of \$4,307, earnings from interest and dividends from investments of \$235,583, and reimbursed expenses of \$7,184.

Benefits under the plan are provided by this Fund. Plan expenses were \$3,205,604. These expenses included \$185,861 in administrative expenses and \$3,019,743 in benefits paid to participants and beneficiaries. A total of 2,463 persons were participants in or beneficiaries of the plan at the end of the plan year, and all of these persons have earned the right to receive benefits. All benefits are paid directly by the Fund. There are no insurance contracts for any benefits.

### A Brief NOTE

#### ACTIVE BURIAL BENEFIT IMPROVEMENT

— Effective September 1, 2005, we have improved your burial benefit from a strict taxable benefit, to a tax free life insurance policy. We have retained Aetna Insurance to provide a \$10,000 benefit for your designated beneficiary: a \$2,000 burial benefit for your eligible spouse/domestic partner and a \$1,000 benefit for your eligible dependent children. All death benefits are tax free.

#### RETIREE BURIAL BENEFIT IMPROVEMENT

— Effective September 1, 2005, we have improved your burial benefit from a decreasing taxable burial benefit, to a tax free life insurance policy. Your designated beneficiary is now entitled to a fixed \$7,500 tax free benefit regardless of age! Please have your beneficiary notify the fund office as soon as possible to report a death. We will be honored to inform that person of what needs to be done (continuation of coverage, other monies forthcoming).

Now would be a good time to check your beneficiaries to see that they are as you desire. You can change your beneficiaries for the above mentioned by filling out a new card with the Fund Office. All you have to do is give a call to request new beneficiary cards. You can use our website with your password to verify your beneficiary is correct.

# Message From Secretary-Treasurer FERBER



#### **Active Members Prescription Drug Program**

This is a reminder of the changes that have occurred with your prescription drug program effective July 1, 2005, and the effects these changes have on you. The plan is very complicated, with different co-pays for formulary, non-formulary and generic medications. When dealing with Express Scripts, be mindful that it is a huge corporation that services many different clients — health benefit plans, unions and non-profit organizations.

There is a good chance that you have three different drug prescription plans for which Express Scripts is the pharmacy benefit manager. They are GHI (GH3), pICa (APN), and Local 444 (L44a).

Let me tell you what prescriptions are covered under each plan.

Diabetic medication is covered by your base medical coverage through a New York State mandate. That means that if you have GHI, you will use your GHI coverage (GH3) for that medication.

The PICA plan, which turned to IC, covers injectable and chemotherapy drugs. This group identifier is APN.

Last but not least is the union's prescription benefit coverage. The group identifier is L44a. This covers just about all other prescriptions.

To avoid confusion when speaking to Express Scripts, you must identify which plan you are referring to. Do this by using the appropriate group identifiers in parenthesis above. If you and your dependents get frustrated talking to Express Scripts, feel free to give me a call. I understand your frustration and confusion about the plan. It's complicated, but together we'll be able to smooth out any confusion. Working through all the complications with the plan saves you and the fund money.

#### Retiree Reimbursement for High Option Rider

It is come to the attention of the Trustees that many retirees have not sent in their 2004 pension stubs or direct deposit statements. In order to receive your reimbursement for the High Option Rider, you must do so. If you are missing your 2004 stubs, call NYCERS at (347) 643-3000 to obtain a printout and mail them to our Administrator:

This is a summary of the annual report for the Sanitation Officers Compensation Accrual Fund (EIN # 13-6291920) for the plan year ending December 31, 2004. The annual report has been filed with the Internal December 31, 2004. The annual report has been filed with the Internal Revenue Service as required under the Employee Retirement Security Act of 1974 (ERISA).

#### BASIC FINANCIAL STATEMENTS

The value of the plan assets, after subtracting liabilities of the plan was \$25,701,999 as of December 31, 2004, compared to \$22,923,349 as of January 1, 2004. During the plan year, the plan experienced a increase in its net assets of \$2,778,650. This increase included unrealized appreciation or depreciation in the value of plan assets: that is, the difference between the value of the plan's assets at the end of the year and the price that the plan originally paid for those assets.

The plan had a total income of \$5,304,463 including employer contributions of \$2,751,184, transfer of contributions from Local 831 of \$1,540,087, gain on the sale of investment of \$318,809, loss on market value decrease in investments of (\$60,622), and earnings from interest and dividends from investments of \$755,005.

Benefits under the plan are provided by this Fund. Plan expenses were \$2,525,813. These expenses included \$154,080 in administrative expenses and \$2,371,733 in benefits paid to participants and beneficiaries. A total of 1,133 persons were participants in or beneficiaries of the plan at the end of the plan year, and all of these persons have earned the right to receive benefits. All benefits are paid directly by the Fund. There are no insurance contracts for any benefits.

#### YOUR RIGHTS TO ADDITIONAL INFORMATION

You have the right to receive a copy of the full annual reports, or any part thereof, on request. The items listed below are included in that part:

- 1. An accountant's report
- 2. Assets held for investment
- 3. Transactions in excess of 3% of plan assets

To obtain a copy of the full annual report or any part thereof, write or call the office of Local 444 Sanitation Officers Association, which is a plan administrator, 8510 Bay 16th Street, Brooklyn, New York 11214, (718) 837-9832. The charge to cover copying cost will be \$5.00 for the full annual report, or \$.35 per page for any part thereof.

You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes, or statement of income and expenses of the plan and accompanying notes, or both. If you request a copy of the full annual report from the administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan, 8510 Bay 16th Street, Brooklyn, New York 11214, at any other location where the report is available for examination, and at the U.S. Department of Labor in Washington D.C. or to obtain a copy from the U.S. Department of Labor upon payment of copying costs. Request to the Department should be addressed to: Public Disclosure Room, N4677, Pension and Welfare Benefits Programs, Department of Labor, 200 Constitution Avenue, N.S., Washington, D.C.

## Clearing Up the Confusion about Optical Benefits

While the glasses you get through our Union's optical providers may help you see more clearly, they won't help you figure out some of the confusion arising lately as members take advantage of what the plan offers.

Though there are several Providers on our panel, General Vision Services (GVS) is the one with the best benefits for our members. Often referred to as "The Optical Company with the Union Label," GVS offers the best value on frames — any style, color and size up to a retail value of \$150 unless indicated otherwise. To utilize the optical benefits, it would be best to visit one of the GVS flagship stores.

Lately there have been a few issues arising regarding the Optical Providers, who contract with private optical businesses to be on their panel. When this is done, the optical businesses are obligated to honor whatever agreement the Provider has set up with our Union. However, there seems to be a loop hole.

If you look at the locations of the Providers' participating businesses, you might see the same address on varying Provider's literature with different names of doctors or businesses themselves. As far as I'm concerned, this is not ethical and can sometimes even be illegal, depending on the contract.

We have also encountered some optical businesses leaving one Provider for another, with little or no time for us to communicate this information to our members. We are currently trying to remedy this situation.

That's why I'm informing you now of what to watch out for and what steps you should take to best avoid any problems. First of all, I recommend you call the Provider's 800 telephone number, or better yet use their web sites, to search for one of their locations nearest you. Remember, GVS is our "Preferred Provider."

When you call one of the Provider's optical locations, ask if they are still a GVS affiliate, and if they accept the Sanitation Officers — GVS Plan. Once at an optical office, if you only want to receive what is offered in our benefit plan, state so. There should be little or no cost to you if you stay within the parameters of our benefit plan. If you're not sure about something, ask. Once you start going out of the plan's parameters, the expense to you can go up quite a bit.

Another thing to remember is that our Union's home base is in New York. Even though most of us have a right to live somewhat out of this area, we are still a New York-based entity. Unfortunately for our Retirees who live out of state, the optical benefits can vary quite a bit, sometimes due to varying state laws. Keep in mind that our Providers do have networks across the country, but the benefits will probably differ from the benefits in the New York area.

Remember, the value of your benefits is \$80 for Active members and \$100 for Retirees.



## Local 444 Says Good-Bye to Brother Lawrence Marcelis Clark


